

Congratulations on the purchase of your Kineticopro® Water System.

Kineticopro Incorporated warrants that the Products identified below are free from material defects in materials and workmanship. Any defective part will be replaced at no charge for the part if any failure caused by the defect occurs within the following time periods originating from the date of original system installation.

This Limited Warranty does **NOT** include freight or labor charges.

What is Covered?

I. Softeners*

- 5** Five years on Kineticopro Hydrus Smart Start Control Commercial Systems and Kineticopro Hydrus Simplex and Multi-tank Commercial Systems
- 4** Four years on Kineticopro Compact Commercial Softeners, Kineticopro Commercial Plus Softeners, Kineticopro Water Softeners and Kineticopro Softeners (ambient temperature models)
- 2** Two years for Hydrus Elite+ Smart Start Control System including solenoid valve and pressure switch
- 1** One year on Kineticopro Compact Commercial Softeners (high temperature models)

*(*When oxidizing agents are present, the softener must be a Kineticopro Carbon Combination System or be preceded by a Kineticopro Dechlorination or CRS System. Additionally, the carbon, Chloraban® or Sulfaban™ media in these systems must be maintained and replaced according to the system's operating instructions. If these conditions are not met, the ion exchange resin is not covered by this Limited Warranty.)*

II. Filters / Manifold Housings

- 5** Five years on Kineticopro KPMF/SMF, HPF, QCM and QC Manifold Housings in original configuration and Kineticopro Hydrus Smart Start Control Commercial Systems and Kineticopro Hydrus Simplex and Multi-tank Commercial Systems
- 4** Four years on Kineticopro Commercial Plus Filters, Kineticopro Water Conditioning Systems, Upflow Dechlorinators and Chloramine Reducing Systems (CRS) Systems
- 2** Two years for Hydrus Elite+ Smart Start Control System including solenoid valve and pressure switch

III. Membrane Systems

- 1** One year on all Kineticopro H-Series, LNP-Series, NSC-Series, R-Series, ROAX N-Series, S-Series and W-Series commercial reverse osmosis systems

IV. Other Warranted Products

Other Kineticopro products, components and accessories that are not specifically mentioned elsewhere in this Limited Warranty [including but not limited to storage tanks, valves, pumps, filter housings and electrical controls] and/or not manufactured but distributed by Kineticopro through authorized dealers, are covered for a period of **one (1)** year from date of purchase. All replacement parts are covered for a period of **one (1)** year from the date of purchase.

V. Replacement Parts

Any replacement parts for Products specifically identified in this Limited Warranty shall be warranted for the remainder of the Products' original warranty period, only. All new replacement parts not mentioned elsewhere in this Limited Warranty are covered for a period of **one (1)** year from the date of purchase.

Who is Covered?

This limited product warranty is transferable by the original owner to a subsequent owner.

Extension of Limited Warranty to a Subsequent Installation

The ORIGINAL OWNER may **NOT** move the system to another location.

Limits on this Warranty

This Limited Warranty for Commercial Applications covers Kineticopro Water Softeners, Filters, Membrane Systems and Deionization Systems installed in any application other than a single family dwelling. Your system must be installed, operated and serviced in accordance with Kineticopro's recommendations and any applicable codes in order to receive coverage under this Limited Warranty. The design of the overall treatment system and the performance of your system is related to the chemistry of the water being treated; therefore, this warranty is limited solely to the equipment manufactured and distributed by Kineticopro, including replacement product and parts.

This Limited Warranty on the commercial reverse osmosis membrane **does not** include damage due to scaling, iron and bacterial fouling or freezing. Periodic replacement of membranes, filter cartridges and certain filter media (such as Macrolite®, carbon, Birm*†, calcite, Filter-Ag*†, Chloraban® or Sulfaban™ media) is part of the normal maintenance required by your system. These replacements and media loss due to natural attrition are not covered.

This limited warranty does not include damage to your system due to:

- Abuse, misuse or neglect
- Excessive pressure (as specified on product's data sheet)
- Excessive water temperature (as specified on product's data sheet)
- Freezing, alterations or misapplication
- A change in the influent water characteristics
- Power surges
- Influent water conditions outside product data sheet specifications
